

# Grant Application Form Guidance February 2025

# Introduction

Thank you for your interest in applying for a grant from Health24. This guidance document is designed to assist you in completing the grant application form and provide important information about the application process, eligibility, and submission requirements.

# February 2025 Application Round

There are two types of grants you are able to apply for:

Large grant applications (grants that do not meet the small grant criteria or are over £5,000, up to a maximum of £30,000) can be made for:

- Employee costs (though there needs to be evidence of future sustainability if the role is not time-limited)
- Equipment
- Consultant or independent contractor time
- Project specific running costs

Projects should demonstrate value, be of 12 months maximum duration, and ready to start within 3 months of receiving any grant awarded.

Small grant applications (up to £5,000) can be made for:

- Equipment
- Organisational and project support (but excluding staff salaries and on costs)
- Specific revenue project costs

Small grants should be spent within 6 months of receipt.

# 1. Eligibility Criteria

Before completing the application form, please ensure that your organisation or project meets the following eligibility criteria:

#### Legal Status

Applicants must be registered charities, non-profit organisations, or community groups.

#### **Project Focus**

Projects must align with our areas of focus, which include:

- Asylum seekers/refugees
- Child and adolescent mental health
- Child poverty

We particularly welcome applications relating to projects which tackle health inequalities.

#### **Geographic Location**

Projects must be based in one of the following areas:

- Halton
- Knowsley
- Liverpool
- St Helens
- Sefton
- Warrington

#### **Financial Requirements**

Projects must have a clearly defined, itemised budget, and the grant requested must be used solely for the purpose outlined in the application.

# 2. General Instructions

- Please complete all sections of the application form. Incomplete applications will not be considered.
- Ensure all supporting documents requested are included with your submission.
- Be clear and concise. Use simple language to explain your project and its expected impact.
- Only one application per organisation will be accepted per grant cycle.

# 3. Section-by-Section Guidance

## Section 1: Applicant Information

This section asks for basic information about your organisation and the person responsible for the application.

## Section 2: Project Details

Provide a clear overview of your project. Ensure your project is well-aligned with the funding priorities of Health24.

### **Section 3: Impact and Outcomes**

Explain the difference your project will make and how you will measure success.

## Section 4: Organisational Capacity

This section assesses your organisation's ability to deliver the project successfully.

## Section 5: Budget and Funding

Provide a detailed breakdown of your project's financials.

## Section 6: Additional Information

This is an opportunity to provide any further details that you think would support your application.

## Section 7: Declaration

Ensure the person completing the application signs this section to confirm the accuracy of the information provided.

# 4. Submission Instructions

#### Deadline

The deadline for submitting the application is **Friday 28<sup>th</sup> March 2025**. Late applications will not be considered.

#### **Submission Format**

Applications can be submitted via the online application form. If you have any questions during the application period, please contact <u>health24@pc24.nhs.uk</u>.

#### Acknowledgment

You will receive a confirmation email upon submission. If you do not receive this within 48 hours, please contact <u>health24@pc24.nhs.uk</u>.

Please note: Applications must be completed in full for consideration.

## 5. Assessment Process

- All applications will be reviewed by our grant committee and assessed using a scoring matrix.
- Shortlisted applicants may be contacted for additional information or interviews.
- Decisions will be communicated by 30<sup>th</sup> April 2025.
